**CALL FOR POSTER ABSTRACTS**

The National Association of Pediatric Nurse Practitioners (NAPNAP) Hawaii Chapter is sponsoring the 12<sup>th</sup> Annual Pediatric Conference on April 29, 2009 at the Japanese Cultural Center. The NAPNAP Conference Planning Committee invites you to submit a poster abstract describing a research study, case study or practice innovation in the areas of professional practice or education. A review process will be completed to determine which abstracts will be selected. Selected abstract presenters will receive a scholarship covering the registration cost to the NAPNAP conference April 29, 2009. A total of 8 posters will be selected. Only one waived registration fee per poster.

**Requirements:**

- Abstract content should be current research and / or clinical practice issues, and should focus in the area of Maternal/Child Health practice.
- Research must have been initiated and / or completed within the past five years.
- Research in-progress or completed are eligible
- Funding sources should be noted on the abstract.
- Use of product name / brand names is allowed in the body of the abstract and in the poster presentation.
- The company should be identified by city and state when first mentioned. Subsequent references do not require further identification of the company.
- An individual may submit more than one abstract regardless of designation of author, co-author, or sponsor.
- In cases of multiple authorship, the presenter of the paper is to be listed as the first or primary author.
- Poster will be displayed **freestanding and able to fit on a 3-foot** wide display table.

**Selection of Abstracts:**

- Abstracts will be reviewed and selected by a committee.
- Selection will be based on clarity, logical consistency, and coherency of research.
- Unless specified, the first author is requested to be present at the conference with the poster exhibit.

**Preparation of Abstract:**

- The abstract is to be typed **single-spaced** on **one 8- ½"** X 11-inch sheet of paper with **one-inch margins** on all sides.
- Use 12 point font size, Arial
- The heading must include the title of the presentation in CAPITAL LETTERS, the author's names (with given names first and surnames last), affiliation, city and state.
- The title should be limited to 10 words, but clearly indicate the nature of the subject.
- Abstracts may be submitted via email at [stark@hawaii.edu](mailto:stark@hawaii.edu) OR with 3 hard copies of the abstract (for review purposes).
- Do not send poster session materials with the abstract.
- Be sure to complete the information on the abstract form (see attached).

**Due Date:**

Please submit abstracts by **March 15, 2009**, otherwise it will not be included in the review process for the Conference.
